SECTION A-A



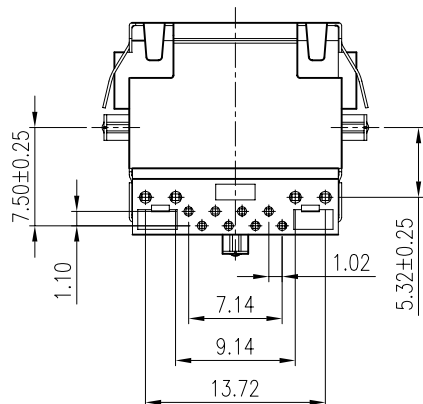
